What Is the Summer School?

The 37th UALE Northeast Summer School for Union Women, Saturday, July 28 – Thursday, August 2, 2012, is a five-day residential program, sponsored by the United Association for Labor Education (UALE). The school brings together rank-and-file members, staff, and officers of unions and workers rights organizations to strengthen their knowledge and understanding of the U.S. labor movement, and to develop skills that will prepare them to be more active members and leaders. UALE advocates education as an essential tool to develop new activists and leaders who will grow and transform the labor movement.

The Program

All students attend classes designed to teach and improve leadership skills. In addition, each student chooses three skills workshops—one four-day workshop and two two-day workshops. There are evening activities and opportunities to network. Summer school instructors are union officers, staff, and labor educators from universities and unions. All workshops will be held at the University of Massachusetts Amherst Campus Center. Workshops may include:

- Collective Bargaining
- Labor Law
- Radio Waves
- Basic Grievance Handling
- Advanced Grievance Handling and Arbitration
- Public Speaking
- Internal and External Organizing
- Safety and Health
- Mobilizing for Political and Legislative Activity

This year's school will be hosted by the labor programs at the University of Massachusetts and held on the university's Amherst campus. UMass Amherst is accessible by car, train, or bus. Travel information will be included in your registration packet and is also available at www.umass.edu/ visitorsctr/Directions_to_Campus/.

The \$565 residential fee includes tuition, housing, meals, and parking for the five days of summer school. Residents will be housed on campus in air-conditioned apartments. Each apartment consists of four single bedrooms, two bathrooms, kitchen, and living room. All rooms are non-smoking. The \$325 commuters fee includes tuition, two meals/day, and parking.

Scholarships
