ricula on workers' rights that can be used and/or adapted to meet the needs of their constituents and students. Participants from the training session have begun leading sessions on the various topics in their classes and organizations.

Labor Extension Coordinators also led a demonstration workshop on the curriculum at the recent conference of the AFL-CIO and the United Association for Labor Education (UALE). More than twenty labor educators from around the country participated in the Introduction to Basic Legal Protections on the Job session.

The next step for the curriculum is piloting, which will occur through early summer. Feedback on all sessions is being solicited, and will be used by Labor Extension coordinators to make changes that will strengthen the curriculum. The goal is to have a final curriculum ready in the fall, and to secure funding to translate the curriculum into Spanish and possibly other languages. Through this project, the Labor Extension Program hopes to develop the leadership of a broad range of workers, and in so doing help to build a stronger and more effective labor movement. The Resource Corner

UMass Labor Extension wants you to know about a website that we have found especially useful—the AFL-CIO's Food and Allied Service Trades site at http://www.fastaflcio.org. Through this site you can access four resources: the Manual of Corporate Investigation, the union busters and healthcare data files, and ordering information for the Labor CD. The Manual is a classic and contains a step-by-step guide for researching private and public companies, with specific pointers on where to find each piece of information needed for organizing or bargaining. The background infor-

mation on union busters and healthcare data is comprehensive and designed to give you tools to take on the busters and also to research health care resources, including surveys, finances, and state-by-state links.

Finally, the Labor CD contains a wide array of indexes to use for research, including a list of NLRB elections and petitions, unfair labor practices, wage and hour law compliance, EEOC cases, and petitions regarding NAFTA-related job loss.

If your union is affiliated with FAST, access to these materials is free and the CD costs \$20. If your union is not affiliated, access to the resources is \$25 and the CD costs \$100. The [???] of affiliated unions is also on the site.

UMASS AMHERST

The major Labor Extension project this winter was putting the finishing touches on the Workers' Rights curriculum developed by the statewide program. We continued to work on plans for a Workers' Center in the Pioneer Valley in coalition with the Pioneer Valley CLC, the Anti-Displacement Project, the WNEC School of Law, the Pioneer Valley Project, the Workers Roundtable and Legal Services. Winter trainings included Assertiveness for the MNA, strategic conversations regarding unfunded contracts and budget cuts for the UMass Amherst campus unions, and Personal Planning and Support for Early Education and Care at WILD in the Winter West. We also worked with the Massachusetts AFL-CIO's Education Committee to plan a spring education conference, and continued to work with the PVCLC Women's and Street Heat committees and Working Families Massachusetts.

UMASS BOSTON

This year, UMass Boston Labor Extension has been working on an exciting collaboration with the Women's Institute for Leadership Development to train a new generation of Latina women leaders at SEIU Local 615/254, the Justice for Janitors Local. The participants in the project are rank-and-file members who took on active roles in last year's strike. Labor Extension coordinators from UMass Boston and Amherst worked with WILD on planning the program and developing curriculum, and UMass Boston is also involved in delivery of the training. The project involves monthly workshops spread over the course of the year, plus mentoring by more experienced union women. Workshop topics are chosen jointly by the participants, the union, and WILD. We think this project can be a good model for training that is directly linked to action, and we hope to try it out in other unions in the future.

The Organizers Roundtable

Union organizing can be lonely work. Although organizers may spend much time talking with workers they want to organize, they are often isolated from other organizers—people with whom they can share experiences and hone their organizing skills. This is one reason that Jobs with Justice, the UMass Boston Labor Resource Center, and the AFL-CIO came together in 1997 to form Mass Organizers, better known as the Organizing Roundtable.

Since then, the Roundtable has met virtually every month to discuss issues of importance to organizers. Meetings are open to all union organizers, including those from non-AFL-CIO unions. Organizers from related community organizations, such as Jobs with Justice and the Jewish Labor Committee, are also welcome.

Topics for future discussions are chosen each month by the participants. Often, guest speakers come to share their expertise. At other times, participants discuss their own campaigns.

Mass Organizers has provided mutual support and cross-fertilization of ideas among organizers from a wide spectrum of unions, and has launched projects such as the Member Organizer Trainings sponsored by Labor Extension and the Massachusetts AFL-CIO.

Program Notes

UMASS DARTMOUTH

This spring, UMass Dartmouth Labor Extension has been involved with an extensive planning process for the Southeastern Massachusetts Labor Council's Leadership Retreat, held over a day and a half in April. The retreat, which was sponsored by the national AFL-CIO and was led by Kim Wilson and Sandy Felder, looked specifically at how our Labor Council can work for working people's justice in economic development. This spring, we have also met with high school students on worker rights and labor history, and we hope to do more of this work. We held our annual Worker Memorial Day road race. We are glad to have worked with the statewide Labor Extension Program to complete the Worker Rights Curriculum, which we hope to widely distribute!

UMASS LOWELL

The final step of the Worker Photo Project, the participants exhibit, is now on display at the Mogan Center. The exhibit includes photos of the Lowell community and workplaces in the region. We continue to work with the developing Workers Center of the Merrimack Valley Project. We are supporting the growth and development of the new Merrimack Valley Central Labor Council, which kicked off publicly with a very successful legislative breakfast on an icy day in early April. We are developing a workshop on Bush and Romney's "war on workers," which will examine a range of issues—from the war in Irag and USA PATRIOT and Homeland Security Acts to the attacks on workers' right to bargain, to put in overtime, and to have a union. This workshop will be offered at the WILD Summer Institute and the Northeast Women's Summer school, both of which we are involved in planning.
